**RESOLUTION OF CALWA RECREATION AND PARK DISTRICT APPROVING REVISED FEES FOR  
THE DISTRICT FACILITIES AND PARKS**

**2024-2025**

**WHEREAS**, Calwa Recreation and Park District has adopted reasonable fees for the use of District Facilities and Parks;

**WHEREAS**, the District periodically reviews all fees during the budget process and as needed;

**WHEREAS**, the District has determined that the District’s Facilities and Park fees be amended to reflect the reasonable cost for providing the services and to allow for affordability; and

**WHEREAS**, after review and consideration, it is deemed by the district administrator that it is in the best interest of the district and its residents that certain fees be adjusted

**NOW, THEREFOR, BE IT RESOLVED**, by the Board of Directors of the Calwa Recreation and Park District as follows:
